

Seats are allotted only to all such Institutes who are willing to take such students.

## Procedure and eligibility

- To get a seat under SAARC quota, the eligible candidate of SAARC Country has to apply in the format available in the website of NCHMCT and such application should either be forward through the education officer/ authorized officer of High Commission of India at the respective Country or through the authorized officer of High Commission/ Embassy of the country (the student belong) in India. Ministry of External Affairs of Govt. of India is extending scholarship up to two students within this quota. The candidate has to apply for the same to the concerned officer at High Commission of India at that Country in the prescribed form of MEA.
- To get a sponsored seat under the reserved quota for LD Countries, the students of such Country has to apply through the authorized officer at the High Commission/ Embassy of India at that Country to forward the request to the concerned officer of Ministry of Commerce, Govt. of India, New Delhi for getting Indian Govt. sponsorship and further forward to the NCHMCT for confirmation of admission.

- Other than the above admission quota, the willing FN/ NRI/ PIO, having the eligibility criteria given below may address their application to:

- IHMs/ FCIs, where the seats for such candidate are on offer can also facilitate the eligible and willing candidates, but such applications should be addressed to the Director (Admn. & Fin.) of NCHMCT and the admission should not be confirmed till the eligibility and other condition is verified and approval of admission is sent to the Institute by NCHMCT.
- Candidates must fulfill the following eligibility criteria.
  - Pass 12<sup>th</sup> standard in 10+2 system of Senior Secondary examination or its equivalent from recognized Board/Institution by securing not less than 50% marks in aggregate.
  - Must have English as one of the subjects at 10+2 level and must qualify the subject in 12<sup>th</sup> standard.
  - Those appearing in above qualifying exam can also apply on provisional basis. Provisional admission will stand cancelled if proof of having passed the qualifying examination is not submitted at the time of admission or latest by **30<sup>th</sup> September** of admission year.
  - For NRI candidates, they must have three years education in a foreign country inclusive of 11<sup>th</sup> and 12<sup>th</sup> level or equivalent.
  - In case of other candidate, the 12<sup>th</sup> equivalent qualification of any country including India is acceptable.
- There is no age limit.

Students admitted in the 1½ year diploma, are Charged for one year only and not for the 6 month period of their Industry attachment. However those are admitted in 1½ year P. G. Diploma, are charged a proportionate amount for the 6 month period of their tenure.

### **Timeline to apply for admission under the Quota**

Duly filled in application should reach to this Council latest by 30<sup>th</sup> June every year positively.

### **Applicable rules for such students**

Students admitted under the scheme are liable to the Student's Disciplinary Rules, Ante-Ragging Rules, Hostel Rules, Library Rules and other such rules in force in the Institute. They are liable to abide by all the uniform code, conduct code as applicable to the Indian students.

### **Indian Agency for equivalency of qualification**

Association of Indian Universities (AIU) is the agency consulted for equivalency of the required qualification of the candidates, if required to ascertain the eligibility. The charges of AIU are to be paid by the student only.

### **Relaxation of Timeline and other conditions**

Chief Executive Officer will have the authority to relax the Timeline of receipt of application as mentioned in the Clause 14 and other conditions contained in the scheme on getting satisfactory reason for such relaxation.

## About NCHMCT

National Council for Hotel Management & Catering Technology (NCHMCT) is an autonomous body under Ministry of Tourism, Government of India. ## INDUSTRY INTERNSHIP / TRAINING

Course content for each of the above Degree & Diploma level programs are designed with an in-built component of industry training or internship, which complements the theory and laboratory work. Marks are awarded for such industry release, which impact the performance of the students. Therefore, the industry training is a very important component in the course.

### RESERVATION OF SEATS FOR STUDENTS OF SAARC COUNTRIES

- Total **25** (twenty-five) seats in all affiliated Central/State Government IHMs across India taken together for admission to 3-Year B.Sc. HHA Program are reserved for students from SAARC Countries who fulfils the above eligibility criteria.
- **5** (five) seats in each of the 1½ Year Diploma Programs are also reserved for students from SAARC Countries who fulfils the eligibility criteria as indicated.

### RESERVATION OF SEATS FOR STUDENTS OF LEAST DEVELOPED COUNTRIES (LDCs)

- **One** seat is reserved for each country in 3-Year B.Sc. HHA Program, which will be offered to candidate who fulfils the above eligibility criteria.

***Admission to candidates is subject to fulfilling the eligibility criteria and on first come first served basis.***

## COURSE FEE PAYABLE BY STUDENTS FROM SAARC COUNTRIES

### For 3-Year B.Sc. HHA Program

Admitted candidates will have to pay the course fee at par with Indian students in Indian Rupees. Course will be paid in 6 (six) installments.

### For 1 ½ Year Diploma Courses

Fees for these Courses is different from Institute to Institute as the fee is fixed by the Institutes within the overall ceiling prescribed by NCHMCT.

## COURSE FEE PAYABLE BY STUDENTS FROM LEAST DEVELOPED COUNTRIES (LDCs)

### For 3-Year B.Sc. HHA Program

Admitted candidates will have to pay the course fee at par with Indian students in Indian Rupees. Fee will be paid in 6 (six) installments.

*In addition to above, medical fee, identity card fee, student activity fee, locker fee and hostel charges, if availed, are to be paid extra at the Institute where admission granted.*

## AVAILABILITY OF HOSTEL

## HOW TO APPLY

### Candidates from SAARC Countries

Eligible candidates from SAARC Countries are required to send their application form to their respective Embassies in New Delhi, which will be further forwarded to Director (A&F), National Council for Hotel Management and Catering Technology, A-34, Sector 62, NOIDA-201 309 (UP), India, after necessary verifications/endorsements. In the application form, candidates will have to indicate the Course name and Institute in which they are interested to get admission. Format of Application is with this Brochure.

### Candidates from Least Developed Countries (LDCs)

Eligible candidates from Least Developed Countries are required to submit their application to the designated Officer of Ministry of External Affairs in Indian Mission located in their respective countries which will be forwarded to Director (A&F), NCHMCT, Noida along with security clearances. Application forms may also be sent through office of Ministry of External Affairs in New Delhi along with their security clearances. In the application form, candidates will have to indicate at least 5 choices of IHMs in priority order in which they would like to get admission. Depending upon the vacancy, IHM will be allotted to the candidate. Admission will be on first-come-first-served basis.

*After admission to any of the prescribed course in IHMs/SIHMs/FCIs affiliated to NCHMCT, all the admitted students will have to abide by all such regulations and disciplinary rules prescribed by NCHMCT and the concerned Institute.*
